Create communications plan - Town website page, town-wide email, social media (Susan Wright)



Create process and methods for soliciting, reviewing, and approving proposals for vote at town meeting. (on Hold). **Bill Bernhart** will draft a process flow, work with others.

**Charlene** to get a ruling on the required procedure for processing tabled items. The meeting moderator will need to facilitate processing to achieve Committee goals. **Charlene** will look into clarification of the actual process required (for tabled items to come before town meeting). Is this a legal issue or a point of order? Can we use WPCA as example to test the required process?

# Susan and Kris to provide some clarification regarding SLFRF and other ARPA funding sources

#### OPEN or not known?

**Charlene** will work on getting someone to transcribe future minutes. **Jon Joslow –** Chester EDC to reach out to other area EDC's on impact to small businesses, for example Old Lyme, Clinton

#### New Business ARPA Proposal Submissions

#### Approved at Town Meeting 12/15

- Proposal for a Contribution Not to Exceed \$10,000 to the Shoreline Food Kitchen & Pantries for Purchase a Refrigerated Food Truck
- Proposal for a Contribution Not to Exceed \$70,000 for Purchase of a Fire Boat

#### Complete - Review and Move Forward to BoS and BoF

- Water Pollution Control Authority (WPCA) Proposal to Repair or Replace Aging Sanitary Sewer (\$98,480)
- ARPA Proposal for IT Updates to Chester Town Hall and Meeting House (\$60,000)

#### Also Tabled at Town Meeting 12/15/21, Will these be resubmitted under the new process

- Town Hall Generator (\$120,000)
- Tri-Town Youth Services Bureau (\$44,820) Have Essex and Deep River approved?
- Chester Public Health and Social Services (\$50,000)



#### New Proposals Received?

- Have any more been received as a result of publishing the process and form?
- Proposal for an ARPA Social Services Fund (ARPA-SSF) (\$100,000)

#### **Discussion**

- Police Body & Car Cameras (\$40,750) and Supporting IT Infrastructure (\$80,000).
  - Note that purchase of body cameras has been approved by BoS & BoF under emergency declaration to meet mandate deadline of July 1, 2022. Solutions for supporting IT Infrastructure are being studied. Should ARPA funding be used for Infrastructure and to cover Camera purchase? Should an ARPA funding request(s) be generated? Several towns are using ARPA funds for this purpose.
- Chester Public Health and Social Services Landscape.
  - How can we best meet the spectrum of need in Chester using ARPA funding to create/support infrastructure while meeting the requirements for ARPA funding accountability and the confidentiality requirements of some service programs?
  - Should we create a unified proposal that allocates funds separately to public health and social services or create multiple proposals?
