## **Chester Park and Recreation Commission Park Fee Schedule**

Chester residents are free with photo identification. Six people may enter, including a household member, per household, free of charge. Additional guests are \$3 per person. People who live in a group setting in Chester are residents. *Guests must be accompanied by the Chester resident*.

Chester taxpayers, that are not residents, are to show photo identification and proof of taxpayer status. The parks are not for use by their employees or customers unless they purchase an annual pass. Six people may enter, including the taxpayer, per taxpayer, free of charge. Additional guests are \$3 per person.

A caregiver, accompanying a resident, is free with their identification, and a signed letter and proof of residency or taxpayer status, from the resident or taxpayer guardian. Additional guests are \$3 per person.

Chester nonprofit groups, cooperatively owned taxpaying entities, or taxpaying businesses, may purchase a park pass for \$120 that can be transferred among members of that group or others. Individual residents and taxpayers may also purchase a park pass for \$120 that can be transferred to their family or friends who are not residents. The pass will be for up to 6 people. Additional guests are \$3 per person.

Non-residents may purchase an annual park pass for \$120. The pass will be for up to 6 people who reside in the household or are guests, accompanied by a member of the household. Identification and the pass are required for entrance. Additional guests are \$3 per person. Non-residents may purchase additional passes that are transferable.

The annual pass covers a period through June 1 of the following year. Daily passes for non-residents are not sold.

## Please display a pass or public access sticker in the front windshield of your car at unstaffed parks or during unstaffed hours.

Groups = any group of 10, to a maximum of 60, including parties, childcare, family gatherings, etc. ALL GROUPS MUST SUBMIT A "GROUP USE APPLICATION FOR CHESTER PARK FACILITIES" AND A CERTIFICATE OF \$1,000,000 LIABILITY INSURANCE NAMING THE "TOWN OF CHESTER" WITH THE APPROPRIATE FEE AS INSTRUCTED ON THE APPLICATION.

The applicant must be a Chester resident, taxpayer, or park pass holders and pay a fee of \$20 for a group of 10 to 20 people, \$40 for 21 to 40 people and \$60 for 41 to 60 people, per day, for use of Pelletier Park during staffed hours.

Groups at unstaffed parks or during unstaffed hours at Cedar Lake must apply to the Selectman's office.

## Parks & Recreation sponsored activities have priority.
