- 1. To select the method of payment and due date of installments of property taxes in keeping with CT General Statutes 12-143 as follows:
 - a. Real estate taxes due in two halves, first half due July 1, 2021 and the second half due January 1, 2022
 - b. All motor vehicle bills due in one payment on July 1, 2021
 - c. All motor vehicle supplement bills due in one payment on January 1, 2022
 - d. Minimum interest charge of \$2.00
 - e. Negate all bills under \$5.00
- 2. To adopt a budget for the Town of Chester for fiscal year July 1, 2021 through June 30, 2022 an amount totaling \$14,860,993, as recommended by the Board of Finance.
- 3. To adopt a five year Capital Budget, as recommended by the Board of Finance.
- 4. To authorize the First Selectman and Treasurer to borrow such sums of money from time to time as may be necessary to defray expenses of the Town in accordance with authorized appropriations of fiscal year ending June 30, 2022.
- 5. To appropriate the sum of \$100,000 from the unassigned general fund balance, to Capital Non-Recurring line item # 10-05-62-1000-150.
